

AUTHORIZING THE PORTAGE COUNTY AUDITOR TO ADVANCE PAYMENT OF LOCAL TAXES COLLECTED FOR THE 2020 TAX YEAR, PAYABLE IN 2021 AND PROVIDING FOR IMMEDIATE ENACTMENT

WHEREAS, Ohio Revised Code Section 321.34 requires local authorities to annually request by resolution the advance payment of local taxes.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TALLMADGE, COUNTIES OF SUMMIT AND PORTAGE, STATE OF OHIO:

SECTION 1. That the Portage County Auditor is hereby authorized pursuant to R.C. 321.34 to make advances of local taxes for the 2020 tax year, payable in 2021 from the county treasury to the City of Tallmadge.

SECTION 2. That it is the City’s intent to use the money for purposes as allowed by law in the current fiscal year.

SECTION 3. That the Director of Finance shall certify, if necessary, that the funds advanced and received have been paid into the appropriate funds.

SECTION 4. That the Clerk of Council, upon passage of this Resolution, shall deliver a certified copy to the Portage County Auditor.

SECTION 5. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees on or after November 28, 1975 that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 6. That this resolution is necessary to provide for and to accomplish the purposes herein set forth, which are conducive to the health, safety, and welfare of the citizens of Tallmadge. For that reason, provided this resolution shall receive the affirmative vote of three-fourths of the members of Council and approval by the Mayor, it shall be enacted immediately and shall be of immediate effect.
